+ Why?

All proceeds from this fundraiser will go towards paying for dedicated locker facilities so our high school hockey team has a home at Pop Whalen Ice & Arts Center for the next 40 years (and counting).

- Choose your sponsorship level and mail a check to PO Box 790, Alton NH 03809. Please write "Scratch-to-Score" in the memo field. We also accept Venmo, just ask us.
- We will sell the scratchies all season long. These will be printed before the holidays and we think they'll make great stocking stuffers!

+ Benefit to You

- Your business will be listed on the back of the Scratch-to-Score card and on our website.
- Your business will be listed in our annual Roster Booklet handed out at every home High School hockey game. There are 20 (twenty) scheduled home games and two tournaments this season.
- You'll feel like a really good person who does things to help others 😊

+ Details

- Depending on the number of donations we are able to secure, Scratch-to-Score tickets will be priced from \$5-\$10 each. We are hopeful to get enough donations to do a printing of 1000 tickets with each one being a winner.
- Friends of Kingswood Hockey will be splitting up your donation into smaller donations to create a maximum number of winners at different values.
 - Example 1: B's Express Mart donates \$200, we may split that donation up into the following awards. (50) \$2 OFF purchase, (20) \$5 OFF purchase. This way, this donation would net us 70 different awards for one business.
 - Example 2: The Hearing Aid Shop donates a pair of Sennheiser OTC hearing aids with a \$999 value. This award CANNOT be split up and must be a single award.
 - Example 3: We will also accept cash awards from businesses and individuals. For instance, the Smith Family wants to contribute \$1000, we may offer a single \$1000 award, OR, we may decide to break the award into (50) \$25 cashback awards.

All award collections will have an expiration date of 12/31/25. If a person doesn't claim their prize by 12/31/25 - you are off the hook.
